

OFFICIAL RULES AND REGULATIONS

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. SWEEPSTAKES PERIOD: Starts September 16, 2026, at 3 p.m. Central, and ends September 18, 2026 at 5 p.m. Central (the "Sweepstakes Period").
2. ELIGIBILITY: Must be 18 years of age or older, and a legal resident of the fifty (50) United States or the District of Columbia to enter.
