

OFFICIAL RULES AND REGULATIONS

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. **SWEEPSTAKES PERIOD:** Starts Wednesday 5/13/2026, at 1:00 PM ET and ends Wednesday 5/13/2026 at 2:00 PM ET (the "Sweepstakes Period").
2. **ELIGIBILITY:** To enter the Sweepstakes, you must also be a legal resident of the fifty (50) United States or the District of Columbia who is 18 years of age or older. Sweepstakes is void where prohibited.
