A proprietary blend containing rosemary oil for control of spider mites and small, soft bodied insects, including but not limited to aphids and whiteflies, on all plants including food crops.

DIRECTIONS FOR USE

READ ENTIRE LABEL – USE IN ACCORDANCE WITH LABEL INSTRUCTIONS.

THIS PRODUCT IS A CONCENTRATE AND MUST BE DILUTED BEFORE USING. Use dilution immediately - Do not store diluted solution.

A minimum of 100 gallons of finished solution to treat 1 acre recommended.

Suggested Spray Rates: 0.25% is preventative (32 fl oz./100 gal), 0.5% for moderate infestation (64 fl oz./100 gal), 1.0% for heavy infestation (128 fl oz./100 gal), 2.0% for rescue from heavy infestation (256 fl oz./100 gal). **Suggested Dip Rates:** 0.25% is preventative (32 fl oz./100 gal) 0.5% for moderate infestation (64 fl oz./100 gal).

NOTE: The use of surfactants, adjuvants, and/or penetrants is not required when using this product.

NOTE: Since plant varieties are numerous and may react differently to TetraCURB Concentrate, test the product on a small scale before making large-scale applications. Do not apply on plants under stress or when the temperature is 90°F or above.

MIXING INSTRUCTIONS

Fill a clean tank with half of the amount of needed clean water. Add TetraCURB Concentrate for the desired rate of application. Fill the tank with the remaining amount of needed water and mix to obtain a homogenous mixture.

APPLICATION DIRECTIONS

For spray applications: Apply the mixture using a clean sprayer to achieve complete coverage on the plant and all leaf surface until runoff.

For best results, use in an IPM program with a minimum of 2-3 applications of TetraCURB Concentrate over a 2-week period.

For dip applications: Make the dip mixture by diluting the appropriate amount of TetraCURB Concentrate to fill a container to allow full submersion of the clippings to be treated. A fresh TetraCURB Concentrate solution should be prepared for every 3000 clippings and should be used immediately and not stored. Submerge the clippings completely (30-120 sec) and provide gentle agitation to ensure complete coverage. Remove the clippings from the dip mixture and allow excess to drain as needed.

COMPATIBILITY OF SPRAY MIXTURES

Limited compatibility testing has been conducted for TetraCURB Concentrate with other commonly used chemistries. As such, tank mixing or use of TetraCURB Concentrate with any other product shall be the exclusive risk and responsibility of the user. Consult specific product labels for additional information. Conduct a tank mix compatibility test when you plan to mix TetraCURB Concentrate with other products and test the mixture on a small scale before making large-scale applications.

STORAGE AND DISPOSAL

Storage: Do not contaminate water or food by storage and disposal. Store in original container in a cool, well-ventilated, dry place (20 – 27 °C). Do not freeze. Keep container closed when not in use. **Container disposal:** Nonrefillable container. Do not reuse or refill this container. **If empty:** Offer for recycling if available or reconditioning if appropriate or puncture and dispose of in a sanitary landfill, or by incineration. **If partly filled:** Call your local waste agency for disposal instructions.
